

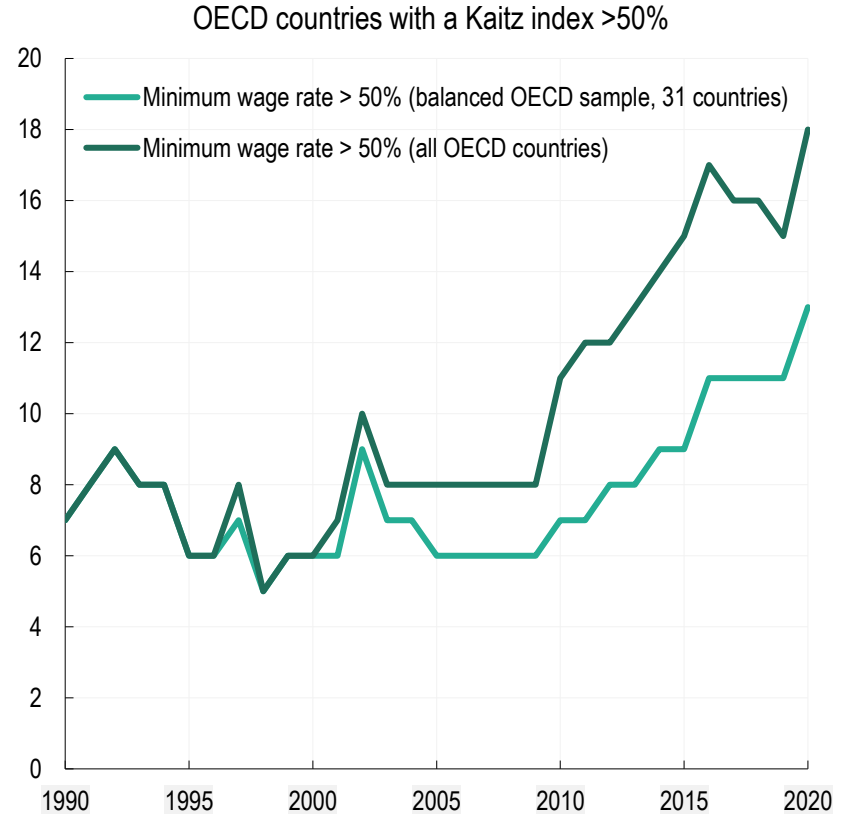
Minimum Wages Are Increasingly Popular

A widespread institution

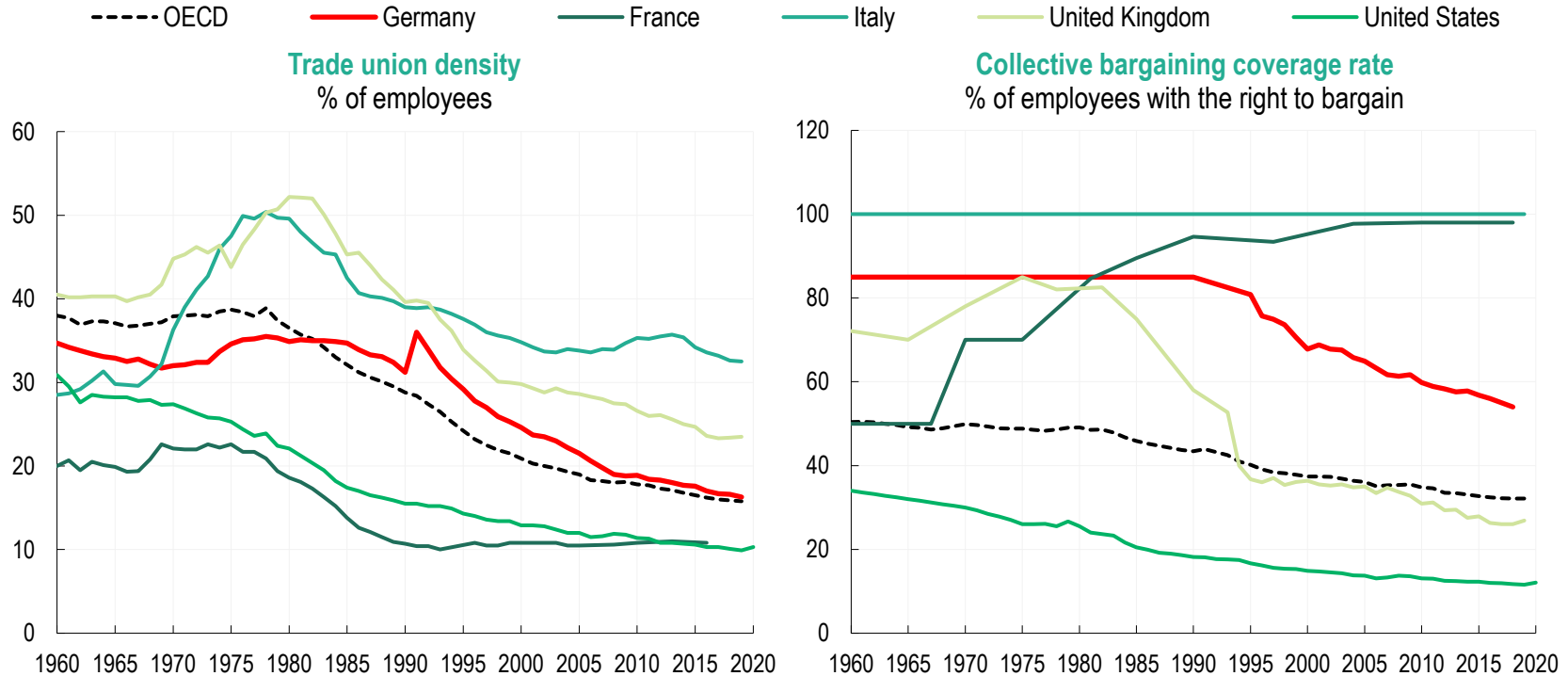
- Minimum wages exist in 90% of ILO member states (but only 79% of OECD countries)
- Developing countries have increasingly turned to the use of MW as part of broader welfare policy interventions
- But also back in fashion in several OECD/EU countries



More and more used...



...partly to compensate for the steep decline in collective bargaining coverage...



...but also thanks to a change in the policy stance

OECD Jobs Study in 1994:

“Reassess the role of statutory minimum wages as an instrument to achieve redistributive goals, and switch to more direct instruments. If it is judged desirable to maintain a legal minimum wage (...), consider minimising its adverse employment effects, including by (...) ensuring sufficient differentiation in wage rates by age and region.”

OECD Jobs Strategy in 2018:

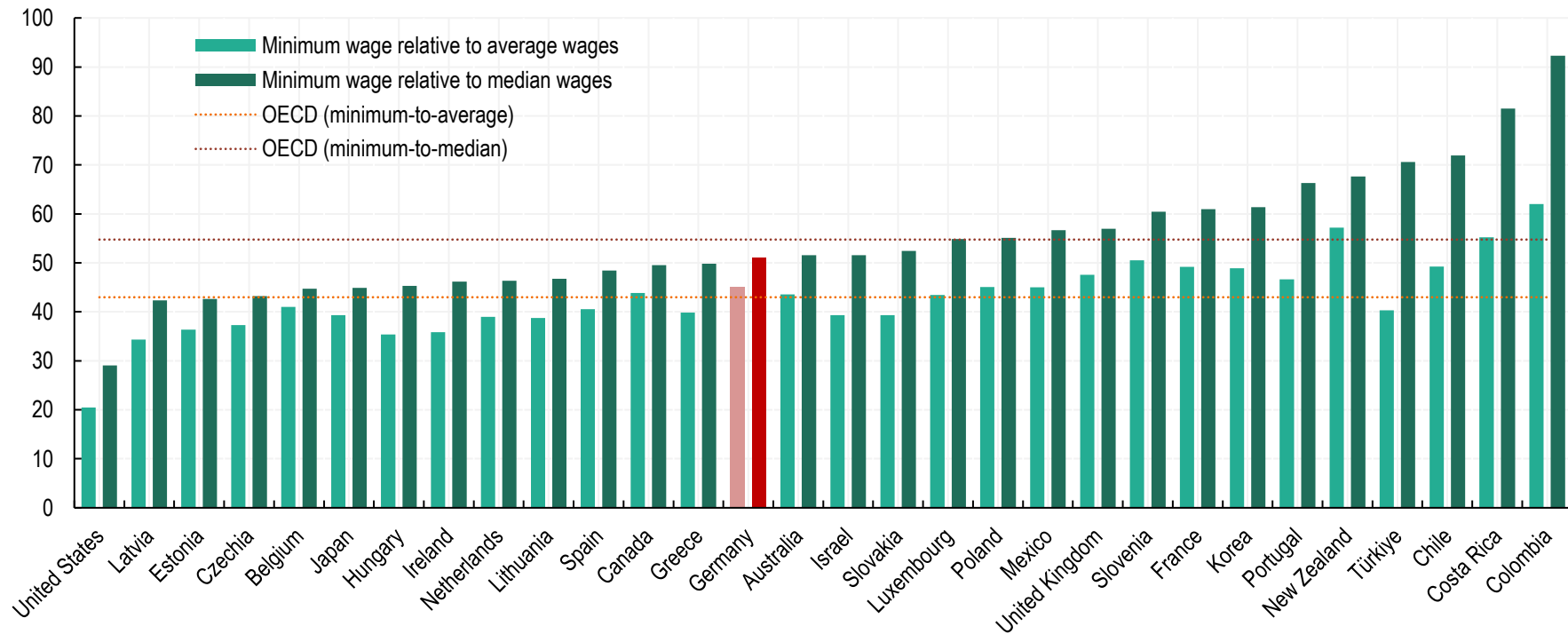
“Consider using a statutory minimum wage set at a moderate level as a tool to raise wages at the bottom of the wage ladder, while avoiding that it prices low-skilled workers out of jobs.”



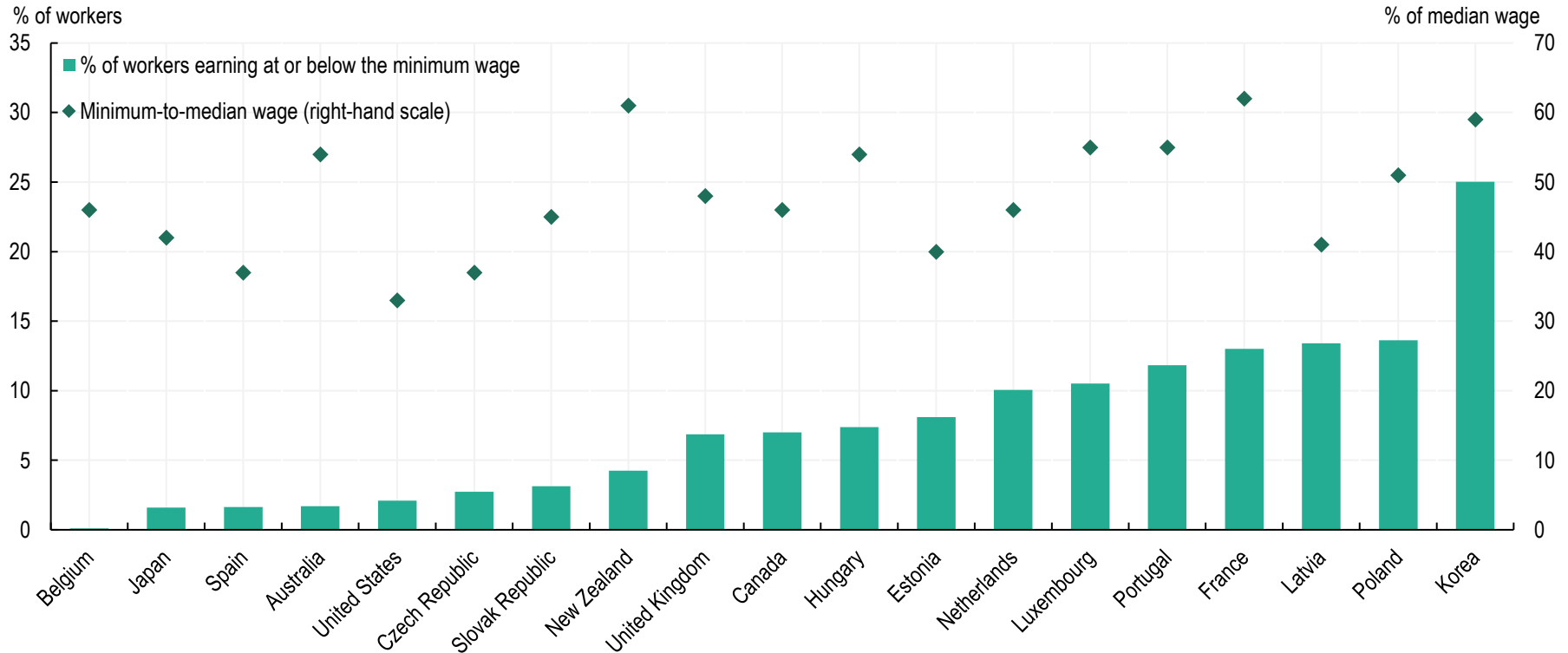
There is no one minimum wage like the other

Statutory minimum wages and collective bargaining coverage in EU countries, 2021

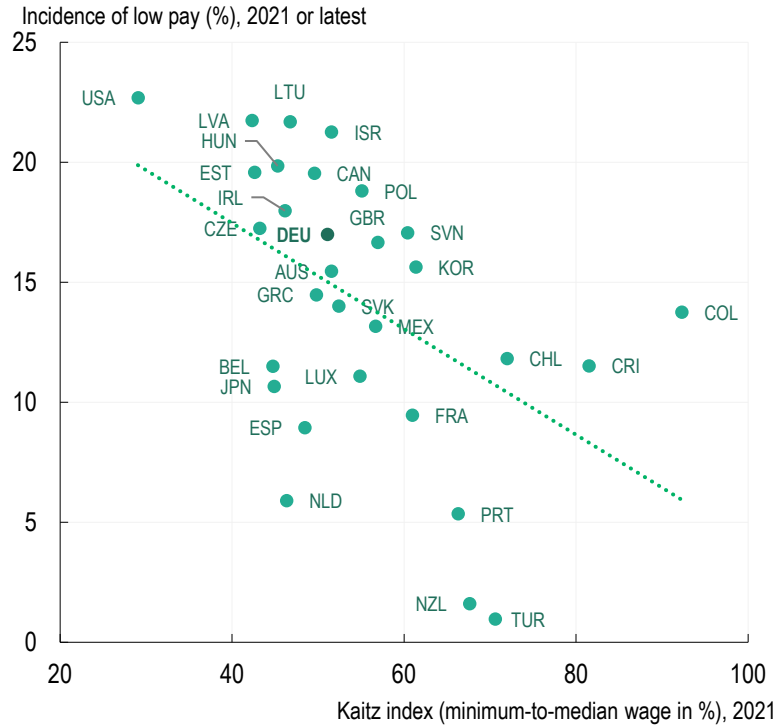

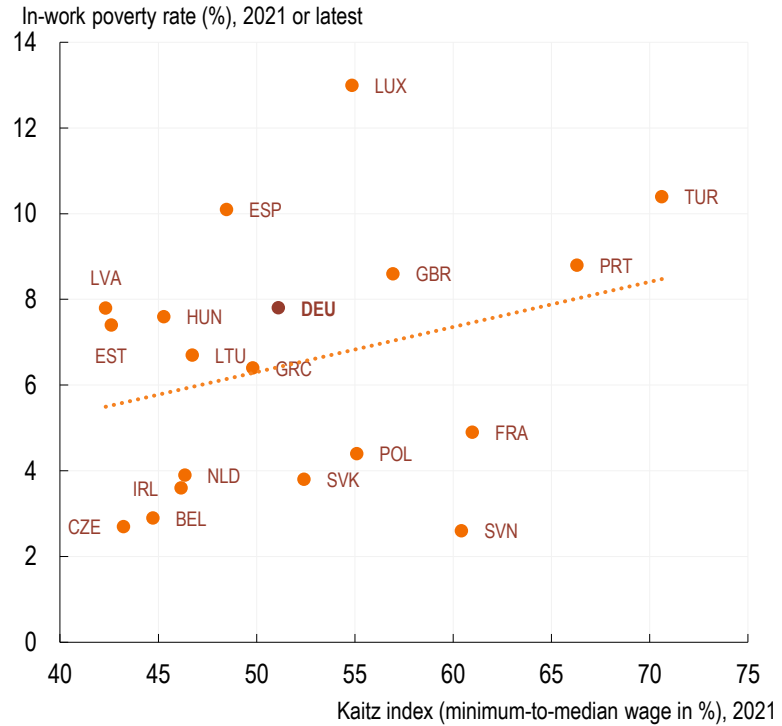

Minimum wage and incidence of low pay

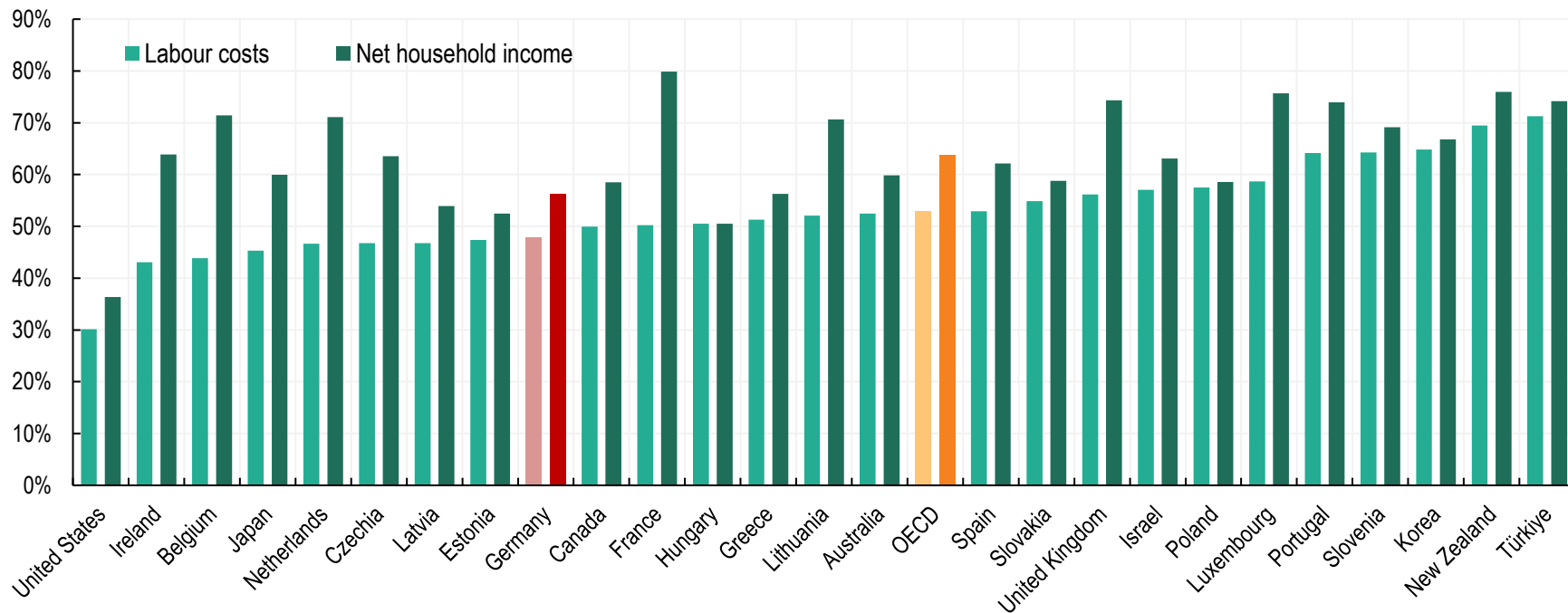


Minimum wage and in-work poverty



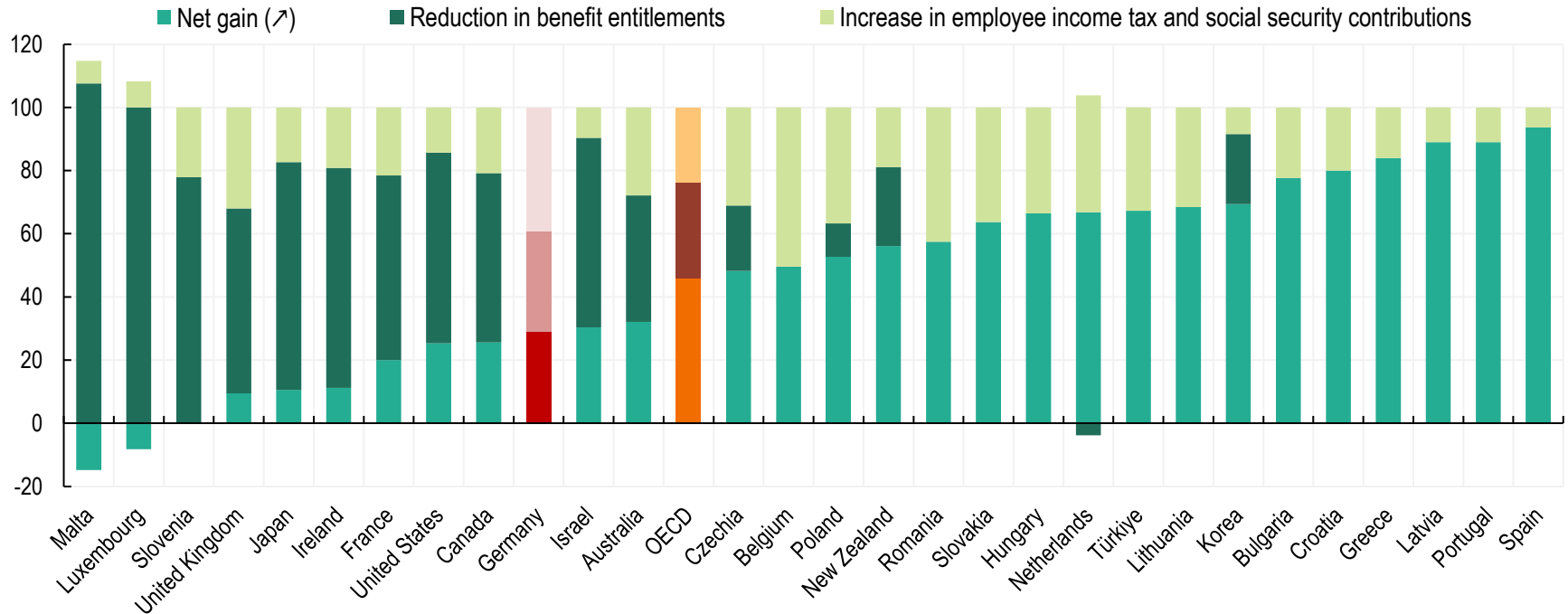
The interaction with the tax & benefit system matters

...for minimum wage earners

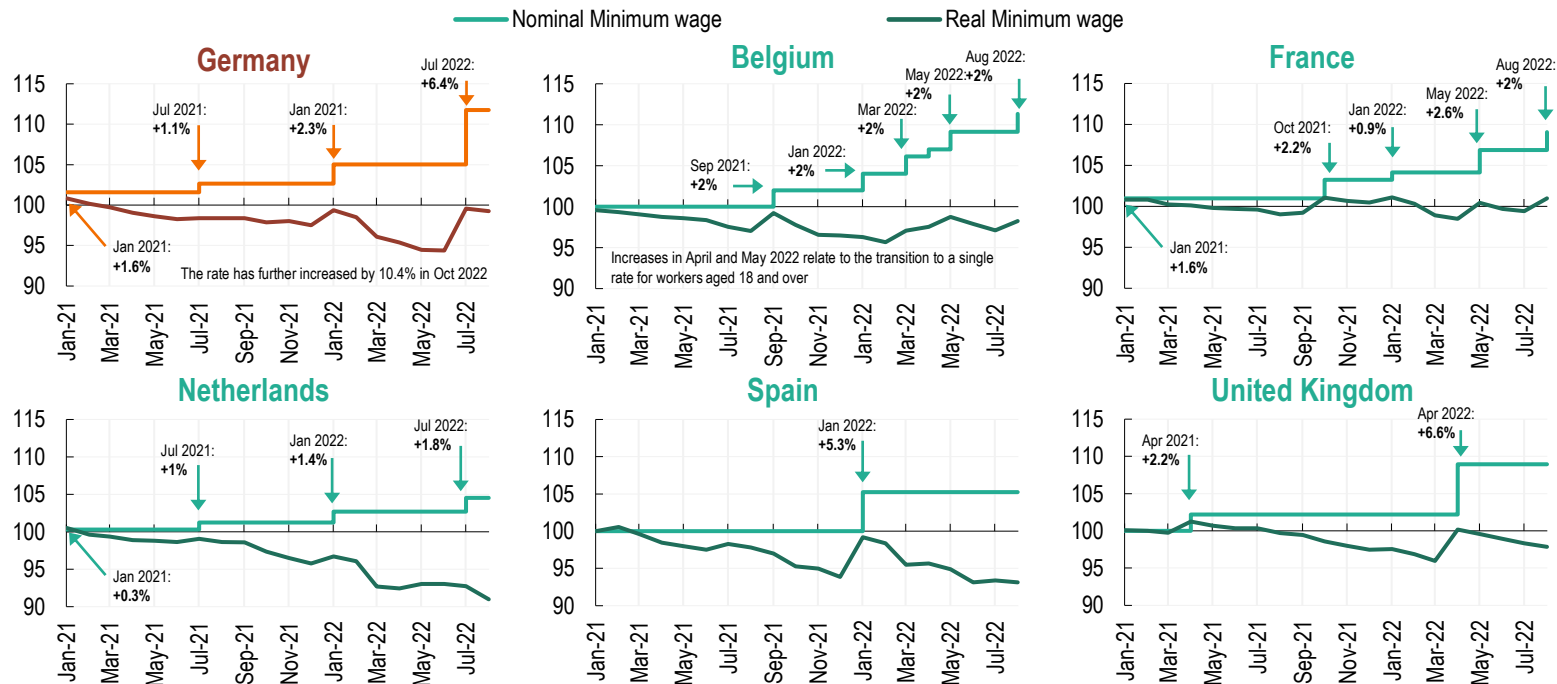
Share of minimum wage increase that is left after taxes and benefit reductions,

Minimum wages in times of soaring inflation

Minimum wages struggle to keep up with soaring inflation...

Nominal and real minimum wage, base 100 in December 2020, Jan 2021-Aug 2022



...which is bringing back the debate on the pros and cons of indexation

	Indexation mechanism
Belgium	Past CPI excluding alcohol and tobacco and petrol but including heating fuel, gas and electricity (every time CPI increase by 2% or more since last increase)
France	Past CPI for the bottom quintile (every time CPI increase by 2% or more since last increase) + half real salary increase of blue-collar workers (annually)
Luxembourg	Past CPI (every time CPI increase by 2.5% or more since the last semester)
Netherlands	Predicted wage developments for the next six months using a basket of collectively agreed wages.

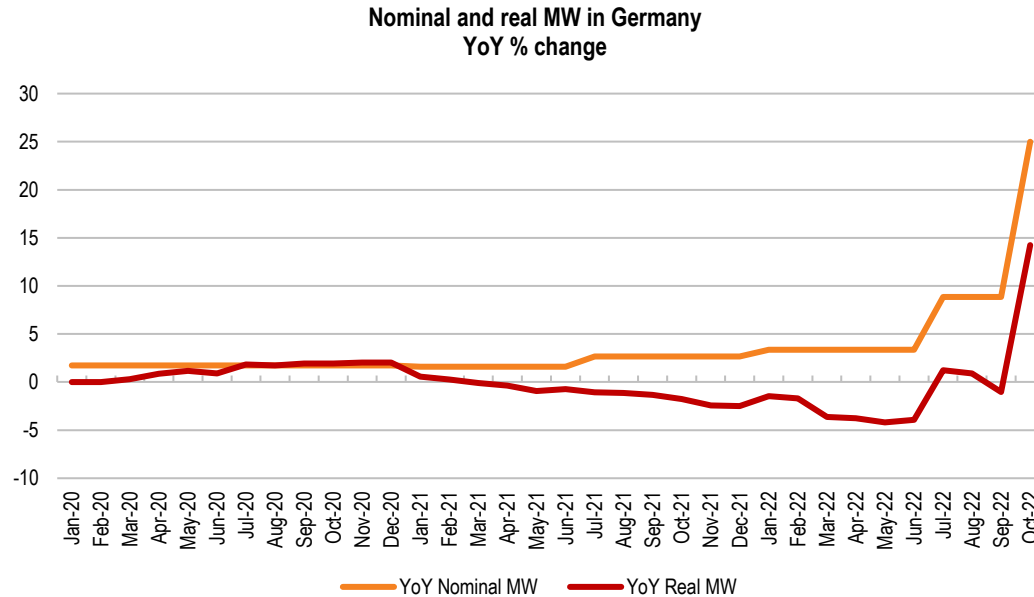
